Brief Overview:

This Safe Driving Program is a training program developed for company and fleet post licence drivers. It has been designed as a stand alone program or can be used in conjunction with existing driver training. The main topics cover a broad range of driving scenarios in an 'open book' learning environment.

This safe driving program consists of 15 questions / scenarios with multiple choice answers. The correct answer or explanation will follow after your score has been calculated. All questions require interactive input from the participant.

Some questions have a 2 stage component where bonus points may be earned. While the challenge may be to achieve the highest possible score during this driving program, we believe the greatest benefit for the driver will result from the information explaining the correct or preferred answer from the previous question.

Safe Driving Challenge Section:

Enter the Driver Challenge section by clicking on the appropriate button shown at the Main Menu. A brief check for a saved / uncompleted driving challenge will occur. The first or next sequenced question will then appear. Read the question / scenario information carefully, then select your answer by clicking on the appropriate answer button A, B, C or D with the left mouse button.

Scoring System:

After you have selected your answer, a score will appear on the screen. A correct answer is worth 5 points. For an incorrect answer points are awarded on a sliding scale: 4,3,2,1.

A score of 4 or 3 points would represent some relevant information present in the answer you have selected. A score of 2 points or 1 point would suggest that your answer was incorrect.

Research has shown that a score of 60 out of 75 (80%) is a creditable benchmark to aim for.

Results Print Out:

You can obtain a print out certificate of your participation in this safe driving assessment at the completion of the question and answer section. You must click on the Print button before you Quit and Save your final results to the database.

Certificate of Participation – PDF Format:

You can also save your certificate as a "pdf" file at the completion of the question and answer section. It is also possible to use the print function from the "pdf" file for further certificate copies.

Quit and Save Feature:

You can quit and save your safe driving program at any stage, by clicking on the Quit button displayed at the beginning of each question.

The current information is recorded in the internal database. When you return to the program at a later stage, it automatically continues from your next unanswered question.

Safe Driving Guide:

The Safe Driving Guide contains information relevant to the questions in the Safe Driving Challenge section. It also contains additional information that motorists may find beneficial in understanding the everyday driving process.

Safe Driving Guide Topics:

Vehicle Collision Management: - (include) Sources of Distractions in Collisions Rear End Crashes, Post Traumatic Stress, The Community Cost.

Driving under Special Conditions, Licensing & Driving Requirements, Alcohol, Drugs and Road Accidents, Vehicle Accidents, Philosophy of a Safe Driver, Defensive Parking, Vehicle Travelling Gaps, Tyres and Tyre Pressures, Mobile Phones and Driving, Reactive Driving Techniques, SUV / Four Wheel Driving.

To access the Safe Driving Guide (SDG) anytime throughout the program click on the SDG button. If there is information in the SDG to help you with your current question, the button will take you to the start of the relevant section.

If the SDG button takes you to the Safe Driving Guide Menu, then no direct answer to your question will be found in any specific section. To return to your current question from within the SDG, click on the Return button.


It is suggested that the Safe Driving Guide be read in its entirety as a first step to enhance the program value.



To Login and View Your Company Driver's Participation in the Program


Step 1:

Login in to view all your drivers through the online CMS data system.

As the program administrator you can view your individual driver's participation in the safe driving program.
